KENYON HALL GETS TAX CREDITS

Kenyon Hall has recently qualified for Federal Housing Tax Credits awarded by the Kansas Housing Resources Corporation. These credits are designated to preserve the building and remodel it to create affordable rental units for the elderly. This credit will make available \$507,357 a year for ten years to be utilized for the building's renovation.

The Mitchell-Markowitz Construction Company now owns Kenyon Hall. Owner Rick Mitchell was quoted last May on the importance of the tax credits. He stated, "There just isn't any other use for the building.... If we don't get the tax credits, (it's) coming down."

C of E Alumni Association President-Elect Linda (Sadler) Myers, '62, had an opportunity to meet with Mitchell and tour Kenyon Hall in January. She reports that the building suffers greatly from neglect and vandalism. She characterized conditions inside of the building as "far worse than I imagined." She continued, "One cannot take a step in any direction without walking on broken glass. Kids have used it as a party place and left debris everywhere."

Although the tax credits have been awarded, the actual renovation is on

hold due to the current economic situation. The tax credits have devalued since the original application. Their value has declined from 90 to 95 cents on the dollar to 70 to 80 cents on the dollar. These tax credits are sold to investors and are currently being actively marketed.

The completed renovation will consist of 46 units ranging in size from 675 to 915 square feet. There will be a mix of one and two bedroom units. Elevators will be placed at the ends of the hall while the old freight elevator will be redone as a third utility shaft.

The redeveloped Kenyon Hall will be considered "affordable" but not "low-income" housing. Monthly rents are projected to range from \$341 to \$470. The facility will be renamed Kenyon Heights Apartments.

Mitchell-Markowitz is required to work closely with the Kansas Historical Society on every detail of the building's renovation. Linda reports, "The exterior of the building will be restored and maintained as built and the first floor lobby and central hall terrazzo flooring will be cleaned, repaired and maintained. In the chapel, the stage, proscenium arch and stained glass windows will remain with the front half of the room turned into a common room or activity center. The back half will be turned into four apartments, once the balconies are removed and floors constructed."

In light of economic uncertainty, no construction timetable exists. Mitchell is, however, cautiously optimistic that work could begin as early as this July.

Kenyon Hall Pleas Are Heard

As noted above, Kenyon Hall has qualified for federal housing tax credits awarded by the Kansas Housing Resources Corporation (KHRC).

The key contact person at the

KHRC, Mr. Fred Bentley, has been quoted as crediting the strong support of C of E alumni and former staff for influencing the positive action on behalf of Kenyon Hall.

President's Letter

I greet you following our Board of Directors held in Emporia in January. All of the Board was present and following a moment of silence in honor of Dr. John Spencer, we considered the business of the Alumni Association. I will share some of the highlights of the meeting with you.

- 1) We heard a report from Walter Olker representing the PCUSA Foundation. He talked about the New Covenant Fund (scholarship fund) and answered questions from the board.
- 2) Cecil Lane, Treasurer, listed total assets as of December 31, 2008, of \$83,195.90. This represents a decrease from \$127,480.89 one year ago. The loss stems from the current problems all are having with the markets. (Remember we gave \$15,000 in scholarships last year).
- 3) Our membership in the Alumni Association continues to increase. However, with over 1700 newsletters being mailed and just over 500 memberships, we can do better. If you are receiving the newsletter and are not a member of the Association, would you please consider joining?
- 4) Following the Treasurer's report, a motion was passed to limit the 6 scholarships for the school year, 2009-2010, to \$2000 each, down from \$2500 each.
- 5) Chuck Ireland will assist Megan Evans as our webmaster.
- 6) Linda Myers reported that the ESU archives stored in Anderson Library are being packed up for a move to the main campus. When the move is completed, the building probably will then be for sale.
- 7) Linda also toured Kenyon hall and reviewed the plans for converting the building into apartments. She also noted vandals have done much damage to the interior.
- 8) Les Palmer reported the 2010 Reunion would be held at the Kansas City Marriott Hotel on July 1-4. The format will be similar to previous reunions except the Saturday morning breakfast will center on the Hall of Fame recognition.
- 9) Our next meeting will be on July 18, 2009 in Emporia at the First Baptist Church. Following the meeting, all C of E friends are invited to join us for a potluck lunch.

We are very concerned about the loss of assets from our association. Right now we are taking a wait and see attitude. Roger Sager is heading up a group to make some suggestions about our scholarship program at our July Board meeting. If the market continues to slide downward, we will need to take action to protect our remaining funds. We will keep you informed.

Norman Tice is our Nominations Chair and solicits your help with names of potential members for our Board of Directors and officers. Norman's e-mail is netice@cox.net and his phone is 316-524-0995. Thanks to Jean Gilmore for her work over the past six years as our Nominations Chair.

I would be remiss if I didn't thank past President Jim Mathis for his leadership this past year. I know there aren't many who show the C of E spirit as Jim does. Thanks Jim from all of us.

I hope you are making plans to attend the 2010 reunion. I'm sure it will be as fun and exciting as those of the past. Check the newsletter, website and/or your class rep. for further announcements. Our website address is www.c-of-e.org.

The athletic hall of fame has generated a lot of interest among our alumni. Several Presbies and/or their relatives have contacted the committee about the process and their plans to attend, some for the first time. Wouldn't it be great if someone or some group would step up and plan recognitions for other groups who were at C of E? Les Palmer has made arrangements with the hotel to have part of the Saturday morning breakfast room divided, if needed, for other groups to use for recognition during that time. If it's not possible for this reunion, perhaps by the time the next reunion arrives, we can have several groups recognized; they are just as deserving.

Broadview Hotel

The Kansas Historical Society has added Emporia's historic Broadview Hotel to the Register of Historic Kansas Places. Built in 1923, this building has always been Emporia's largest and tallest building, defining the city's skyline.

The hotel was closed and the building was sold in 1964 to a development company with plans to convert the building into luxury apartments. The plans never materialized, and the building was vacant until 1966 when the College of Emporia stepped in and converted the building into a "Downtown Campus Center." The first floor housed college offices and the upper floors served as a dormitory.

In 1972, declining enrollment forced the college to close the dormitory portion of the building. The first floor continued to house college offices until 1974 when the college closed. At that time the school sold the building to another development company who renamed the hotel Broadview Towers. This company converted the building into one of the nation's first FHA senior housing projects. Current plans call for rehabilitating the property for continued use as senior housing.

Athena Society

In the spring of 1910 the Athena Society was established to stimulate and recognize attainments in scholarship. Four members were inducted the first year from the class of 1910. In 1915 the Athena Society voted to recognize the alumni for years preceding 1910. Members were elected from each graduating class who had achieved scholastic honors.

Jean Gilmore has provided the Alumni Association

with a list of Athena Society members from 1890 through 1957. We would like to obtain a list of members from 1958 through 1974 when the college ceased operation. Members of the Athena Society will be recognized at the 2010 Reunion. Please let us know if you were a member or know of a classmate that was a member. Scholarships Continue

The current economic crisis has contributed directly to a reduction in the number of college scholarships available throughout the nation for the 2009 – '10 school year. Moreover, shrinking endowments are expected to lower this number even further in the coming months.

The College of Emporia Alumni Association is pleased that it will once again offer six scholarships in the coming school year. The amount of each scholarship will, however, drop from \$2,500 to \$2,000. This continuation was in part

made possible by a significant financial contribution by a friend of C of E to the scholarship fund.

The selection committee for the College of Emporia Athletic Hall of Fame has spent months going through newspaper articles, college yearbooks and the personal recollections of many C of E alumni to develop a list of individuals and teams worthy of induction. The initial list of nominees appeared in the Fall Edition of this newsletter. Additional names added since that publication date appear found on the back page of this newsletter.

The committee has announced its decision to induct all of the nominees into the Hall of Fame at the induction ceremony slated to take place July 2 - 4, 2010, at the next C of E Reunion at the Marriott Hotel in Overland Park, Kansas.

The committee felt that every nominee met the minimum requirements for induction. Now the committee members are urging every nominee to plan to attend the reunion and the induction ceremony. Families of both living and deceased inductees are also being urged to be present for the ceremony. All nominees are urged to fill out the "Hall of Fame Nominee Information" form found on the back page of this newsletter. This is necessary to assure a complete and accurate chronicle of the achievements that will be listed for each inductee in a booklet that will be presented at the 2010 ceremony. In addition to the booklet, every nominee will receive a Hall of Fame certificate.

Muriel J. (Lewis) Murphy of San Antonio, TX, passed away on September 26, 2008 at the age of 101. She attended C of E in the late 1920's. A daughter, 2 grandsons and two great-grandchildren survive her.

Lorraine (Koontz) Watson, A30, Prairie Village, KS, died October 30, 2008. She was an elementary school teacher who first taught in Kiowa, Emporia and Ottawa, KS. Subsequently, she taught in Kansas City, MO. Her first husband, Leslie Utt, who died serving his country in World War II and her second husband Orville C. Watson, predeceased her.

Esther M. (Anderson) Bicknell, A32, of Carson City, NV, passed away May 27, 2008, at age 97 years, 10 months. Her husband Harold predeceased her. In 2003 she had written, "I have lived in a retirement residence 17 years and am in excellent health." A daughter survives her.

Rosalie (Hanna) Larkin, A33, of Emporia, KS, died December 28, 2008 at the age of 96. Rosalie and her husband, Ralph, who predeceased her, owned and operated Larkin & Co. store in Admire, KS, for 40 years. During this time Rosalie also taught elementary school. She and her husband retired and moved from Admire to Emporia in 1983. 2 children, 3 grandchildren and 6 great-grandchildren survive her. **Three** sisters, Jean (Hanna) Yarlone, **Nelle (Hanna) Finley, A29**, and **Ruth (Hanna) Somers, A34**, predeceased her.

Betty (Davis) Eccleston, A39, Bartlesville, OK, passed away February 17, 2007.

Dr. Kenneth S. Cooper, A40, of Nashville, TN, died September 10, 2008, at the age of 90. He was a retired Professor of History at Peabody College in Nashville, TN, where he taught for 32 years. He retired in 1980. Dr. Cooper also authored a number of textbooks on history and social studies. His wife, **Ruth (Meeker) Cooper, A40**, predeceased him in February, 2003.

Elizabeth (Sipe) Robinson, A41, of Manchester, NH, died November 13, 2007, at age 87. She had been married to Arthur C. Robinson.

Elvin Koger, X43 Springfield, MO, died August 19, 2008. His wife, **Zelda Mae (Renfro) Koger, X43**, had died April 10, 2001. One daughter survives them.

Robert M. Signor, A48, of Kansas City, MO, passed

away on October 12, 2008. He is survived by his wife, **Joan (Williams) Signor, A44**, two sons, grandchildren and great-grandchildren. Signor was a decorated World War II veteran. After the war he completed his undergraduate work at C of E and then obtained an MBA from ESU. He began his career as basketball coach at Emporia High School. After working for several Fortune 500 companies, including Xerox, Signor formed his own executive search company headquartered in Houston, TX.

William K. Goy, X50, of Worth, IL, passed away August 11, 2008 at age 82. He served in the US Navy in WWII. He married the former Helen Littlefield, who survives, along with 2 daughters, one son, and one grandson.

Donn J. Everett, X51, of Manhattan, KS, passed away on November 29, 2007, at the age of 78. Donn was an attorney. He received his law degree from KU. He served in the Kansas House of Representatives where he was majority floor leader. Subsequently he also served in the State Senate.

V. S. McAlister, A52, of Burlington, KS, died October 10, 2005. His wife Mary Ann survives him.

Rev. Charles L. Williams, Jr., A53, of Salisbury, NC, passed away on February 17, 2009. Subsequent to his graduation from C of E, he graduated from the San Anselmo Presbyterian Seminary. He then served as a Navy Chaplain before obtaining a Masters Degree from KU. As a Presbyterian minister he served churches in Kansas, Illinois, Ohio and Iowa. He moved to Salisbury after his retirement.

Ruth Kathleen Keraus, Ph.D., A54, Mt. Pleasant, IA, passed away on February 16, 2009 at age 76. Dr. Keraus joined the music faculty of Iowa Wesleyan College (IWC) in 1960. She spent her entire career teaching there. During her tenure at IWC, she at various times held the posts of Chair of the Faculty, Chair of the Division of Fine Arts and Assistant Academic Dean. One of many letter writers was William G. (Bill) Tolliver, C of E's last Director of Theatre and Chair of the Department of Speech and Drama. He is married to Linda (Fulks) Tolliver, A72.

Bill is now a full time author with three published books, The Fireblade Trilogy, to his credit. His next book, Twilight in Xanadu, is due for publication this spring. The book is an action/adventure novel and will be the first in a new series. Here is his plea to preserve Kenyon Hall.

Dear Sir:

Every college campus has a building that becomes the cultural and academic icon symbolizing the essence of college experience to a student body. Kenyon Hall is such a building. For many years, Kenyon was the hub of college activities such as lectures, concerts, plays, community activities, and religious services. Unlike such "home" buildings on many other campuses, Kenyon also was the location of classrooms, faculty and administration offices, and an excellent, large auditorium where concerts and plays were also performed. It also housed one of the finest pipe organs in the country. All of these qualities helped to make C of E not only an educational institution, but also a home and family for all who worked or attended there.

These things are memories now, and Kenyon stands like a ghost among the more modern structures that surround it, a skeleton through which the wind blows sad and lonely tunes. Pigeons mutter where once students and professors held lively discussions. Thousands of people daily pass by it, having no idea of what it once represented.

Yet it continues to be the element that binds all of us who experienced the College of Emporia—a place that took pride in the excellent individual attention its students received. This was a place far more concerned with the students' education than with "keeping up with the Joneses." It was a place where a teacher's ability was valued far above the letters after his or her name. For many of those who attended, it was not only a place to earn a degree; it was the place where they took their first steps into the greater world outside their youth; it was the place where they won acceptance, and formed friendships that would last throughout their lives, and for many of them it was the place where they would meet their future husbands or wives.

The many generations of students who passed through Kenyon and the other campus buildings contributed to America and to the world in ways that can never be fully estimated. Their loyalty to the school remains ever steadfast. Kenyon was and is a part of their history and experience. It was, and is, home.

Now, though it is sadly in need of major repair, it still stands as a symbol of all our experiences. It is entirely fitting and proper that Kenyon should be preserved—a monument to the sort of education that is tragically missing from the experiences of many modern colleges.

It is within our power to preserve this once-stately monument. Please, let us put forth our best efforts to accomplish this. It would be tragic indeed for former faculty and students to return, seeking some remnant of that which nourished their youth, perhaps hoping to share the memories with their children and grandchildren, and find not Kenyon Hall, but a single stone bench in an isolated corner of the campus they did, and still do, call home.

She is survived by two sisters who attended C of E, **Ellen (Keraus) Wiedman, A45**, and **Margaret (Keraus) Magill, A49**. Another sister, Janice (Keraus) Roberts, A56, predeceased Dr. Keraus.

Frederick "Rick" W. Cruwell, A67, of Ridgewood, NJ, passed away July 19, 2006 at age 64. One daughter survives him.

David L. Shelton, X67, of Palm Harbor, FL, died November 3, 2008, at age 63. He loved journalism and worked for many years at the New Jersey Herald. He was first on scene for Karen Ann Quinlan's saga, was known for his Playboy bunny "sextortion" stories, and his "Bigfoot" story is still being seen 30 years later on the "Bigfoot" Web sites. He also worked in public relations in New York City, was an award-winning journalist for the Tampa Tribune/Hernando Today, and, after semi-retirement, was a journalist for the Largo Leader and Belleair Bee. His wife Sue, two children, four grandsons, and three brothers survive him.

John H. Spencer, MD, A70, of Fort Scott, KS, died on January 3, 2009 at the age of 61. John served the C of E Alumni Association as a Board member, webmaster and Memorabilia Chair. He is survived by a son, daughter and stepdaughter as well as his sister, **Sharon (Spencer) Stewart, A65**. John's father, also a physician who served for many years as the doctor for C of E athletic teams, and mother were both members of the C of E Class of 1931. John graduated from KU Medical School, completed his residency in Michigan and began his practice in Fort Scott in 1977. His lifelong keen interest in history went well beyond his vital roles with the C of E Alumni Association. John was instrumental in creating the Mine Creek Battlefield Foundation in 1999 to assist the Kansas Historical Society in preserving, protecting and interpreting this important Civil War battlefield site near Pleasanton, KS. As a result of John's leadership, the foundation has raised more than a million dollars. This money has been used to purchase and preserve more than 306 acres of battlefield land and to complete numerous interpretative projects at the site that the state of Kansas did not have the funds to implement. One of the hallmarks of John's medical practice was his compassion. When Medicaid began requiring a co-payment from patients, some were unable to afford the required payment. Consequently, they were being denied medical care. John refused to accept this situation and paid the co-pay out of his own funds. John Spencer was a key member of the C of E Alumni Association's Board. He was admired, respected, appreciated and well liked by all. He will be missed.
