Sterling Scholarships

In March of 1977, just 3 years and 3 months after C of E closed, **Dr. William Keesecker, A40** (graduate of the College of Emporia, McCormick Seminary, and a frequent C of E chapel speaker and campus visitor) met with a representative of Sterling College to discuss the establishment of a College of Emporia Endowed Scholarship Fund at Sterling. This

was considered important and was an appropriate way to inform the alumni that the Way College was not a continuation of the College of Emporia. The fund at Sterling started in January of 1981, and was endowed as of January of 2004 when the \$2,000 annual payment from the Alumni Association was terminated with the fund valued at approximately \$30,000. At that time (2005), **Clarence "Clancy" Howland, A58**, our scholarship committee chairman, outlined revised award criteria,

DON'T LOSE TOUCH

Being part of the C of E family started for me in 1953 when I first arrived on campus. Since then, I do not remember being out of touch with C of E activities and friends. How about you? Have you stayed in touch with your old school? Better yet, have you kept the C of E friends you have made? I recently read a list of the top five things people regret as they have reached an older age – and one of those is that they regret not keeping up with their earlier friends.

I came to Salina, Kansas three times for work in churches here. This last time I arrived was in 1995, and I am still here. Also arriving in 1995 was a retired Doctor and his wife who moved into Presbyterian Manor. Dr. Perry Hunsley and his wife Phyllis moved here as she was beginning to develop dementia. Then retired, they looked for a location that would give them support. They came to Sunrise Presbyterian Church, where I had just arrived to be pastor, and it was not long before the discovery was made that Dr. Perry was also a C of E graduate...not only that but he also had an RN through Newman School of Nursing. He graduated from C of E in the class of 1951. He went on to be a

physician in Ohio, Kansas, and Missouri. In 1976 he moved to Branson, Missouri about the time that town was beginning to make its mark in the arts industry. On his arrival he discovered that the medical system there was at ground zero – and did not even have a certified hospital. Dr. Perry accomplished not only that but the development of a full clinic system and a new hospital while he was there.

Sadly, I officiated at Phyllis' funeral. But, our friendship has grown over the years. We often do things together and when I have a medical question I know that Dr. Perry can help me decipher the medical lingo. I want to attest that his being honored at the last reunion as one who was deceased was grossly misleading – he is alive and well and I am thrilled to have him as a good friend. We never knew each other in school but I am convinced that C of E connections have had much to do with the creation of our relationship. It's a real treasure. Who has crossed your path that keeps the college alive for you? Have you called a classmate recently that you haven't talked to in a long while? Give it a try – don't lose touch!

Restoration Under Way

The long awaited Kenyon Hall restoration is now under way. Thanks to federal housing tax credits through the Kansas Housing Resources Corporation work has begun to transform the former focal point of the C of E campus into affordable senior housing.

The building has been vacant since 2006. During that time it has been subjected to repeated vandalism as well as further deterioration related to age and weather. No

significant maintenance or repair work had been done on the building since the late 1970's.

The building's owners, Mitchell-Markowitz, LLC, now have subcontractors cleaning out the building. When completed, the building will be known as Kenyon Heights. Owner Rick Mitchell predicted, "It's going to be one of those landmark properties that will really be an asset to Emporia."

2013 Kansas City Reunion

Planning continues for the July 5, 6 & 7, 2013 reunion in Kansas City. This event will again be held at the Marriott in Overland Park, Kansas. Registration fees and room rates will be roughly comparable to those at the 2010 reunion.
