SUCCESSFUL REUNION

The C of E Alumni Association's 2010 Reunion, held in Overland Park, KS, July 2 -4, was a resounding success. A total of 368 people registered for some or all of the event. Alumni from California, New Jersey, Wisconsin, Florida, Texas and many points in between were among the attendees. **Andreas Vikis, A64**, came from Canada.

There were a number of successful events. The memorabilia room held more artifacts and drew more attendance than ever before. Friday afternoon saw fair weather and a successful golf tournament. Friday

evening saw the humorous, well-told reminiscences of **Laura (Lunsford) Schlobohm, A41**, daughter of C of E icon **Janie May Lunsford**.

Former cheerleaders had several opportunities to lead the entire group in "ein, zwei, drei." Former athletes shared numerous interesting, often humorous, stories from their days at C of E as a part of the Athletic Hall of Fame induction ceremony. Inductees included 34 cheerleaders and 29 individuals in the "Legacy Awards" (1894 - 1950) category. There were 169 inductions of athletes, coaches and managers from the post-1950 era. (The actual number of individuals

MASCOTS THROUGH THE YEARS AT THE COLLEGE OF EMPORIA – 1911 thru 1974

Since writing this history and presenting it at our reunion in July, quite a bit of new information has come my way that needs to be included. No historical article can be complete if knowledge is ignored. I want to thank Roger Klein, Chip Barger, Steve Howard, Laurie Schlobaum, and Jerry Dyche for providing the additional information to complete the story.

We all remember our beloved Presby Pete, the feisty Trojan warrior whose fierce demeanor struck fear into the hearts of all opponents. At least we liked to believe that! However, before our Pete came along, the college had several other mascots, beloved by all in their respective eras. I spent several days this past January, going through every Alla Rah housed in the Lyon Co. Archives, as well as boxes and boxes of donations to our C of E collections. What I learned was surprising, as well as a deserved wake-up call to reinforce that my era was NOT the only one to ever grace the grounds of C of E.

In 1911, the first recorded mascot was a bulldog named Pat. By 1920, Pat had been replaced by a collie named Pucky. This well-loved mascot was mourned by the entire student body when he died sometime before 1923. He is mentioned in a write up about Gwinn Henry cemetery and there was a stone over his gravesite there. I had no idea that something once living was buried along with the spirits of our opponents.

The 1923 Alla Rah depicts a bear-like creature wearing a crown and clown shoes, along with a devil's tail, but he did not last longer than two years. By 1924, our own J. Irwin Beeson and his yell-leader partner, Hall Hibbard, were in charge of another bulldog mascot – this one named "Buzz". He wore a cape with the letter "E" and was the official mascot until 1926.

During the 1940-41 school year, a Scottie dog became the official mascot of the Fighting Presbies. Due to our Presbyterian heritage being from Scotland, it was logical that a Scottish Terrier became the mascot. Laurie Schlobaum couldn't recall his name but he was present at all the games. He would be the last "canine mascot" until the '70s.

Jack Bell came to C of E in the 1940's from Yonkers, NY. He became the art editor for the Alla Rah. Jack gave us "Pete the Presbie", a likable fellow who couldn't make up his mind if he was an angel or a devil – as he wore a halo and had inherited that 1922 bear's forked tail. Pete the Presbie was seen in many formats in the Alla Rahs, with varied themes each year. In 1950, the Alla Rah was dedicated to all the "Pete the Presbys" on campus. By this time, Pete was occasionally sporting angel's wings.

In 1957, a contest was held on campus to find an official mascot. A drawing of a skunk wearing a beanie and carrying a C of E banner won the \$25.00 first prize for Jerry Dyche, but his triumph was short-lived. It was widely believed throughout the campus community that we could only bring ridicule raining down upon us at athletic events by being referred to as "polecats" and other highly descriptive names.

President Sharpe talked with Jerry and the latter agreed to withdraw his submission, but was allowed to keep his prize. A second contest was held and research began in earnest to come up with a likable, appropriate character to portray the Fighting Presbies. Jerry spent hours in the library researching gladiators and looking at pictures of knights from the Crusades. He created some drawings of warrior-like figures with the helmet, armor, shield, and sword "our Pete" wears today. Harvey Paymella was known for his cartoons and he changed Jerry's serious, warrior faces to reflect a cartoon-like character. From Harvey, the drawings went to Roger Rickard and, subsequently, his brother, Jack.

Jack Rickard's submission of Presby Pete as a Trojan warrior won this second contest and was widely accepted with enthusiasm. This Presby Pete is the one we know today.

In 1962 and 1963, Omar Jones became Presby Pete, appearing at games and pep rallies. John Spencer recalled going to the NAIA playoff game in Minneapolis, MN on his 16th birthday. Omar was along, dressed as Pete. It was so bitterly cold that

Howard Mendenhall, A35, of Fowler, KS, passed away February 20, 2010, at the age of 96. He was a basketball player at C of E and was the oldest attendee at the 2007 C of E Alumni Association Reunion. He was the owner of the International Harvester dealership in Fowler for many years. He was predeceased by his wife **Mary Elizabeth (Nelson) Mendenhall, X38**. She died in 2000. His second wife, 4 children, 16 grandchildren, 22 great-grandchildren and one great-great-grandchild survive him.

Harry M. Swift, A36, of Glenview, IL, died March 4, 2010, at the age of 95. He started, owned and operated Western Evergreens Nursery in Golden, CO, for 37 years. His wife and four children, four stepchildren, 20 grandchildren and four step-grandchildren survive him.

Alice (Wells) Arms, A38, of Leawood, KS, passed away at age 101 on July 30, 2010. She was a Magna Cum Laude graduate of C of E and was listed in Who's Who of American Colleges and Universities. Three children, six grandchildren and nine great-grandchildren survive her.

Verl Dean Anderson, X43, of Abilene, KS, died March 26, 2010, at the age of 88. He received his B.S. and M.S. in education from the University of Kansas. Verl had a distinguished career in education serving as Superintendent and Assistant Superintendent of Schools in Russell, KS, and then as Assistant Superintendent in Abilene. His wife and several children and stepchildren along with their families survive him.

Lois Jean (McFerrin) Athon, A46, of Prairie Village, KS, passed away August 30, 2010, at the age of 86. Lois was an accomplished church organist and was a member of the American Guild of Organists. She is the daughter of longtime C of E Physics Professor **William V. McFerrin**. Her brother **Bruce McFerrin, X53**, and a sister predeceased her. She is survived by her husband of 59 years, **Dr. Merrill Athon, X49**, four children, six grandchildren and her sister, **Maxine (McFerrin) Haggerty, A55**.

Barbara R. (Nelson) Scofield, A47, of Newton, KS, passed away on July 28, 2010, at age 85. Barbara was a 1952 graduate of McCormick Theological Seminary and she had a master's degree from Bethel College. She taught school and ended her working career as Christian education coordinator at a local church. Her husband, two sons, six grandchildren and three great-grandchildren survive her. Her sister, **Beverly (Nelson) Holstead, A50**, died in 2006.

Harry Ray James, A51, of Kingman, AZ, died September 13, 2009, at age 82. Most of his career was as a student counselor in the Seattle, WA, school system. Three children and two grandsons survive him.

June (Elwell) Bougan, X51, of Castle Rock, CO, passed away March 10, 2010, at the age of 80. June was a lifelong school teacher (retired in 1991) who loved to sing in her church choir. John F. Wolfe, A62, of Springfield, MO, passed away August 28, 2009, at age 70.

Eva Ursula (Plinton) Weng, A66, of North Brunswick, NJ, passed away on June 23, 2010, at age 67. At C of E Ursula was a cheerleader and was just inducted posthumously into the C of E Athletic Hall of Fame. She worked as a test developer for Educational Testing Service and the State of New Jersey. She was also active in her community having served on various boards including a stint on the Board of the National Urban League (New Jersey chapter). Her husband **W. Lauritz "Laurie" Weng, A67**, predeceased her. He died in 2001. Ursula's mother, her brother, 3 children and 3 grandchildren survive her.

Herman William "Bill" Berning III, A67, of Montauk, NY, died September 18, 2005, at the age of 61. Bill was widely known in his community for his outgoing and kind nature. He owned the local Army-Navy Store. Two sisters survive him.

Beth E. (Winslow) Graham, A68, of Great Bend, KS, died December 3, 2009, at age 63. Her entire career was devoted to teaching, mostly Special Education in Larned, KS. Her husband, **Charles R. Graham, A69**, survives her. Three sons and four grandchildren also survive her.

Stephen C. Peirsel, A71, of Hedgesville, WV, passed away May 11, 2009. He was three days short of his 64th birthday.

Big Game

During the 1933 – 1934 basketball season, the Fighting Presbies traveled to Ottawa for a heated rivalry game. The event commanded considerable attention in Kansas. Governor “Alf” Landon attended the game. The Governor found the time to attend this big game even though he was

gearing up for his successful bid for re-election in 1934 and for his unsuccessful race for the Presidency in 1936. A basket by C of E freshman Dick Lee in the waning moments of the game produced a “thrilling” 32 – 30 Presbie victory.

John remembered trying to restore the circulation in Omar’s legs on the train trip back. Since Pete didn’t wear any leggings, Omar was having some serious problems. Sharon Spencer Stewart wrote on the back of a photo (seen in the “Our Pete” album) “Omar died in Viet Nam”.

The 1966 Alla Rah has a color picture of a student dressed as Presby Pete, standing in a chariot pulled by several male freshmen wearing beanies. Pete Harris has been identified as the one who took on the role after Omar Jones graduated.

During the early ‘70s, Elliott Stein, of Cheltenham, PA, became Pete. He called me on June 19th and gave me some great stories about those football days. He recalled pulling a chariot onto the football field before every game and participating in the funerals after wins. Elliott mentioned another student who played Pete

before him, a “Junior Portee”. Roger Klein provided the missing name – Burnett Portee Jr.

By 1973, “College Life” had ceased production due to cost cutting and “The Daily Planet” took its place. The logo on this sheet shows Presby Pete without “C of E” on his breastplate. Instead, it says “Super Pete”. Chip Barger and Steve Howard have told me it was only used for a correlation between Superman as the reporter, Clark Kent, for “The Daily Planet”.

The Final Walk” shows a dog wearing some type of headgear, with a cheerleader named Rosie, and on the football field before a game. Our last graduate, Steve Howard, told me the dog belonged to a football and basketball player, Doug Wright, and was the unofficial mascot. I find it somehow fitting, or Twilight Zonish, that we began and ended with a dog as our mascot, whether official, or unofficial.

Mary Helen (Kummer) Wallace, A43, celebrated her 89th birthday in July. She is in good health and living in Hearne, TX.

Lois E. (Crowder) Doyal, A43, recently celebrated her 90th birthday. She was joined by seven of her eight children, one grandchild and two great-grandchildren. The celebration included 90 helium filled balloons.

Thelma (Stout) White, A52, has 2 sons, 2 grandsons and 4 grandchildren. Her husband is still farming, and she regrets not being able to attend the reunion.

Joe and Selena (Petersen) Keesecker, A65, are retired and living in Phoenix, AZ. Both acquired Masters Degrees. Joe’s were from McCormick Theological Seminary and the University of Chicago. Selena’s came from Texas Christian University. Their careers in church-related work led them to New York City,
